V. NEW BUSINESS

A. PC12-494ZTA, Text Amendment, Mixed Use District Signage

The Applicant is requesting a recommendation from the Planning Commission to the Mayor and Board of Aldermen for amendments to Section 864 of the Land Management Code (LMC), entitled *Sign Regulations*. (Love)

B. PC12-302FSCB, Combined Forest Stand Delineation/Preliminary Forest Conservation Plan, Homewood

The Applicant is requesting approval of a combined forest stand delineation and preliminary forest conservation plan for 13.05 acres of onsite planting and 1.15 acres of offsite plantings associated with the Homewood development. (NAC #3)(Reppert)

C. PC12-428FSI, Final Site Plan, Genesis Healthcare Facility

The Applicant is requesting approval of a final site plan for the construction of a 59,000 square foot, 130 bed skilled nursing facility along Ballenger Center Drive.

The Applicant is also requesting modifications to Section 605 of the Land Management Code (LMC) entitled, *Landscaping Standards*. (NAC #10)(Mark)

D. PC12-505FSU, Final Subdivision Plat, Ballenger Creek Center, Lots 7 and 8R

The Applicant is requesting approval of a final subdivision plat for the re-subdivision of Lot 8 of Ballenger Creek Center into lots 7 and 8R. (NAC #10)(Mark)

E. PC12-367FSI, Final Site Plan, The Residences on Prospect Hill

The Applicant is requesting approval of a final site plan for the construction of 376 multifamily dwelling units located along the north side of Butterfly Lane, west of Himes Avenue.

The Applicant is also requesting recommendations to the Mayor and Board of Aldermen regarding the deferral of frontage improvements along Butterfly Lane in accordance with Section 309, *Site Plan Review*, and a waiver of the parkland dedication requirements in accordance with Section 608, *Parks and Open Space*.

Lastly, the Applicant is requesting approval of modifications to the following sections of the Land Management Code (LMC): Section 601, *Access Management*, Section 605, *Landscaping Standards*, and Section 607, *Parking and Loading Standards*. (NAC #8)(Love)

F. PC12-368PFCP, Preliminary Forest Conservation Plan, The Residences on Prospect Hill

The Applicant is requesting approval of a preliminary forest conservation plan for 6.97 acres of forest retention associated with the construction of the multifamily development along Butterfly Lane. (NAC #8)(Love)
