

SPECIAL ORDINANCE S-20-07

A SPECIAL ORDINANCE TO AMEND THE BUDGET OF THE CITY OF FREDERICK FOR THE FISCAL YEAR JULY 1, 2019 TO JUNE 30, 2020, TO INCLUDE REVENUE AND ASSOCIATED EXPENDITURES FOR A HEALTH RESOURCES AND SERVICES ADMINISTRATION GRANT

WHEREAS, by Article VII, §5 of the Charter of The City of Frederick it is provided that the budget shall be prepared and adopted in the form of an ordinance upon a favorable vote of at least a majority of the total membership of the Board of Aldermen; and

WHEREAS, the Mayor and Board of Aldermen did meet in public on May 16, 2019 and did by a majority vote to accept and approve the budget, as submitted by the Mayor in a public meeting of the Mayor and Board of Aldermen on March 27, 2019, and as amended by memoranda from the Mayor to the Board of Aldermen dated May 7, 2019 and May 13, 2019 and passed by a majority at the meeting of the Mayor and Board of Aldermen on May 16, 2019 as required by Article VII, §5 of the Charter of The City of Frederick; and

WHEREAS, the Mayor and Board of Aldermen did adopt and enact the budget on May 16, 2019, as required by Article VII, §5 of the Charter of The City of Frederick; and

WHEREAS, the Mayor and Board of Aldermen did adopt and enact the budget on May 16, 2019, to take effect on July 1, 2019, by Special Ordinance S-19-06; and

WHEREAS, subsequent to the adoption and enactment of the budget the City received supplemental funding to assist in the preparedness and response to the Coronavirus outbreak; and


WHEREAS, the Community Health Center budget as adopted and enacted by Special Ordinance S-19-06 must be amended to include grant revenue and supplies expenditures of \$619,490.

NOW, THEREFORE:


SECTION I: BE IT ENACTED AND ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FREDERICK, that the budget for The City of Frederick for the fiscal year July 1, 2019 to June 30, 2020, as submitted by the Mayor in a public meeting of the Mayor and Board of Aldermen on March 27, 2019, and as amended by memoranda from the Mayor to the Board of Aldermen dated May 7, 2019 and May 13, 2019 and passed by a majority at the meeting of the Mayor and Board of Aldermen on May 16, 2019, as required by Article VII, §5 of the Charter of The City of Frederick and as adopted and enacted on May 16, 2019, by Special Ordinance S-19-06, and effective July 1, 2019, be and the same is hereby amended to include grant revenue and supplies expenditures of \$619,490.

SECTION II: BE IT FURTHER ENACTED AND ORDAINED BY THE AUTHORITY AFORESAID, that this Ordinance shall take effect on May 7, 2020.
